



## TERMS & CONDITIONS 2017

- 1) Age.** Students must be 18 years old or over (17 with parental permission)
- 2) Number of Students per class** maximum 8 students per class, 3-5 on average
- 3) Classes** Each class hour lasts 60 minutes. There is one 20 minutes break from 10.50 to 11.10am
- 4) Fees** include: tuition, welcome pack, student information handbook, use of resource centre, free Internet access - placement test and end of course certificate / individual report.  
**The balance must be paid at least 21 days before** the beginning of the course.  
**Fees do not include:** Exam fees, meals, private insurance and bank charges.  
**A registration fee of €40** will be charged on all courses. Registration fee does not include course books. All students must buy a course **book and materials** (according to the number of weeks studied, ex €35 for 2-5 weeks). These fees will be included on all invoices.
- 5) Airport Transfers.** We can arrange for you to be met at Bologna airport and taken by car to your accommodation. The cost of this services is €40 from /to airport and €25 from /to railway station - one way.
- 6) Excursions.** Excursions are not included in the cost (except Master course 45+). Most social and cultural activities are free of charge (please see monthly schedule)
- 7) ALCE Calendar.** The School will be closed on the following public holidays: 17 April, 25 April, 1 May, 2 June, 15 August, 4 October, 1 November, 8 December, from 18 December 2017 to 5 January 2018.
- 8) Accommodation.** All accommodation booked by ALCE is subject to an **administration fee of €30**. If a student changes family or accommodation, a second administration fee may be charged in some cases.
- 9) Insurance.** All students are advised to take out private medical and travel insurance. On request basic public insurance can be provided (up to 6 months 80€, up to 12 months 160€). All EU nationals should bring E1.11 form covering public medical care.
- 10) Visas.** EU nationals do not require Visa. Non-EU nationals should contact their local Italian Embassy or Consulate. Please check the special refunding policy for students who apply for student Visa (Type D)
- 11) Booking and Cancellations:** Cancellation: 60 days before beginning of course: all fees refunded less a charge of €95 (admin. expenses); 30 days before beginning of course: balance will be refunded less a charge of €200 (deposit). If a booking is cancelled between 45 and 30 days before the start of the course you will be entitled to a refund, less a charge of €200 and 1 week of accommodation fees. Between 29 and 14 days (in addition, the accommodation fees - 2 weeks - won't be refundable). If the cancellation arrives late, entire sum will be forfeited. For any individual courses, we have to be advised at least 24 hours before the course so it can be made up.
- 12) Changing Course.** If a student changes the date of a course, an extra registration fee will be charged. If the change is made less than one week before the course start date, one week's accommodation will also be charged.
- 13) Refunds.** No refund can be made after a course has started. In the case of illness, students may ask for a course to be postponed to a later date. In this case the school will require a medical certificate. A course cannot be carried over into the next calendar year.
